OUR PROFESSIONAL CONSTRUCTION STAFF MANAGES OUR BUILD SITES AND OVERSEES OUR PAID SUBCONTRACTORS AND VOLUNTEERS. WE BALANCE THE USE OF PROFESSIONAL AND VOLUNTEER LABOR TO ACHIEVE OUR GOAL OF SERVING AS MANY FAMILIES AND INDIVIDUALS AS WE CAN, AS EFFICIENTLY AS WE CAN.
