We operate a Health Resource Center for low income individuals who are seeking programs that will provide coverage for the health care services they need. Our clinic's Health Resource Center had 5,542 client visits, provided case management to 160 individuals, provided syringe services to 3,112 individuals, distributed 10,736 doses of Naloxone, distributed 640,702 sterile syringes, and had 4,748 outreach encounters.
