RESILIENCY THROUGH THE COMMUNITY PROGRAM: THE CONSORTIUM PARTNERED WITH THE FLORIDA DEPARTMENT OF EDUCATION TO BUILD STUDENT RESILIENCY THROUGH THE COMMUNITY WITH LOCAL EDUCATION FOUNDATION PROGRAMS FOCUSED AROUND 11 SKILLS OR CHARACTERISTICS THAT HELP THEM NAVIGATE LIFE'S CHALLENGES. THE PROGRAM FINISHED IN 2024 AND FUNDS WERE LEVERAGED TO ENGAGE 838,000 STUDENTS, 34,150 TEACHERS AND 350 COMMUNITY ORGANIZATIONS IN LOCALIZED PROGRAMS THAT IMPROVED MENTAL HEALTH, REDUCED CHRONIC ABSENTEEISM GIVING STUDENTS MORE THAN 900 DAYS OF INSTRUCTION, REDUCED SUICIDAL INDEX AND BUILT HOPE WITH PEER LISTENING PROGRAMS, INCREASED CAREER PATHWAYS FOR RURAL COUNTIES AND MANY OTHER PROGRAMS TO BUILD GRIT, GRATITUDE, RESPONSIBILITY AND SELF-MANAGEMENT. MEMBERS HAVE NO SEPARATE VOTING RIGHTS WITH RESPECT TO THE AFFAIRS OF THE CONSORTIUM, AND ALL GOVERNANCE OF THE CONSORTIUM SHALL BE VESTED WITH THE BOARD OF DIRECTORS. MEMBERS VOTE BIENNIALLY ON MEMBERS OF THE EXECUTIVE COMMITTEE (GOVERNING BOARD). THE BOARD ALSO VOTES ON OTHER BOARD BUSINESS AND RECOMMENDATIONS OF THE EXECUTIVE COMMITTEE, INCLUDING DUES, STRUCTURE AND POLICIES.
