Housing Our Workers: Through our Housing our Workers campaign, we convene and connect workers organizations and housing justice groups to advance a shared agenda. In 2022, we built on our tenant Right-to-Organize victory by supporting tenant organizing at the city's biggest landlord, and by bringing union members into the fight to unionize their homes. We also helped secure \$112M from Proposition I to fund an affordable housing agenda that benefits educators. Climate Jobs: We helped launch a new coalition called California Labor for Climate Jobs to push for good union jobs in the new energy economy, and won \$50 million in the state budget to support displaced oil and gas workers. Workers Rights: Through our Workers Rights program, we convene workers organizations and community groups to advance a shared agenda for low-wage workers. In 2022 we mobilized for better conditions for San Francisco public sector workers, public school teachers and gig workers. We launched worker anti-retaliation legislation as policy co-chairs of the California Coalition of Worker Power.
