Empower Her Network collaborates with ready survivors of human trafficking who find themselves in the same vulnerable circumstance that led to their initial exploitation. These women present at high risk for re-trafficking, homelessness, and resorting to sex work. Having been stripped of basic human rights for years and sometimes decades, the women of Empower Her Network face different combinations of intimidating but not insurmountable obstacles. They need assistance tackling societal barriers surrounding housing, education, and unemployment to break exploitation and poverty cycles and remain forever free. Empower Her Network funds those tangible needs while curating confidence, igniting hope, and establishing focus. These skills are purposefully held back from trafficked persons and need to be relearned. Our process is rooted in its strong partnerships with residential shelters and aftercare programs that nominate ready survivors. Empower Her Networks trauma-informed advocates collabo
