THE MERGING OF FUTURES AND STEPPINGSTONE WILL CREATE ONE OF THE MOST DYNAMIC, EXPANSIVE, AND TRUSTED EDUCATIONAL NONPROFITS IN THE CITY OF PHILADELPHIA. THE NEW ORGANIZATION WILL IMMEDIATELY SERVE 3,000 PHILADELPHIA STUDENTS AS WELL AS SIGNIFICANTLY SCALE SERVICES, WHICH WILL CREATE EVEN MORE SUSTAINABLE ACCESS TO ACADEMIC AND WORKFORCE OPPORTUNITIES FOR STUDENTS, ESPECIALLY BLACK, LATINX, AND FIRST-GENERATION STUDENTS.
