THE MISSION OF THE YOUNG WOMEN'S FREEDOM CENTER IS TO PROVIDE FISCAL SPONSORSHIP, OPERATIONAL SUPPORT, COACHING, AND TRAINING TO PROJECTS THAT CENTER SYSTEMS-IMPACTED WOMEN, GIRLS, AND TRANS PEOPLE OF ALL GENDERS WITH THE PRIMARY PURPOSE TO INSPIRE AND EMPOWER YOUNG WOMEN WHO HAVE BEEN INVOLVED IN THE JUVENILE JUSTICE SYSTEM, CRIMINAL JUSTICE SYSTEM, AND/OR THE UNDERGROUND STREET ECONOMY TO CREATE A POSITIVE CHANGE IN THEIR LIVES AND COMMUNITIES.

YWFC ADVANCED ITS MISSION BY SUPPORTING OVER 3,500 YOUTH, EMPLOYING 65 YOUTH STAFF, AND EXPANDING PROGRAMS ACROSS 5 COUNTIES. THROUGH THE FREEDOM CENTER, WE PROVIDED FISCAL SPONSORSHIP, LAUNCHED BELOVED VILLAGE, AND EXPANDED SISTER WARRIORS' WORK IN CALIFORNIA WOMEN'S PRISONS. THIS YEAR, YWFC CONTINUED TO EXPAND ITS WORK IN ALIGNMENT WITH OUR CORE VISION TO SUPPORT YOUNG WOMEN AND TRANS YOUTH OF ALL GENDERS IN TRANSFORMING THEIR LIVES AND COMMUNITIES. THROUGH THE FREEDOM CENTER--THE DIVISION OF YWFC THAT PROVIDES OPERATIONAL INFRASTRUCTURE AND FISCAL SPONSORSHIP--WE SUPPORTED MULTIPLE MAJOR PROGRAMS AND BEGAN SPONSORING ALIGNED EXTERNAL PROJECTS. (CONTINUED ON SCHEDULE O) YWFC'S CORE PROGRAMS REACHED OVER 3,500 YOUNG PEOPLE ACROSS FIVE CALIFORNIA COUNTIES: SAN FRANCISCO, ALAMEDA, SANTA CLARA, CONTRA COSTA, AND LOS ANGELES. WE PROVIDED PAID LEADERSHIP ROLES TO MORE THAN 65 YOUTH STAFF AGES 14-25, AND DELIVERED INTENSIVE COURT ADVOCACY, REENTRY PLANNING, AND CASE SUPPORT TO OVER 400 YOUTH AND WOMEN INSIDE JUVENILE HALLS, JAILS, AND PRISONS. IN ADDITION, WE HOSTED 12 HEALING-CENTERED EVENTS, INCLUDING FREEDOM CIRCLES, KNOW YOUR RIGHTS TRAININGS, AND YOUTH-LED RETREATS FOCUSED ON TRAUMA RECOVERY AND COMMUNITY BUILDING. SISTER WARRIORS FREEDOM COALITION CONTINUED TO EXPAND ITS REACH, SERVING 702 INCARCERATED PROGRAM PARTICIPANTS AND AN ADDITIONAL 128 YOUTH ACROSS THE STATE OF CALIFORNIA. SERVICES INCLUDED OVER 952 HOURS OF SYSTEMS NAVIGATION, 636 HOURS OF REENTRY SUPPORT, AND 306 HOURS OF PROGRAMMING DELIVERED INSIDE PRISON. SISTER WARRIORS ALSO LAUNCHED A SEXUAL ABUSE RESPONSE AND PREVENTION INITIATIVE WITHIN CALIFORNIA'S WOMEN'S PRISONS, CULMINATING IN A PUBLISHED REPORT WITH RECOMMENDATIONS TO INTERRUPT CYCLES OF ABUSE. BELOVED VILLAGE LAUNCHED ITS FIRST PROGRAMMING IN 2024, ENROLLING OVER 20 CLIENTS STATEWIDE INTO A THREE-YEAR PILOT. THE PROGRAM PROVIDES FINANCIAL ASSISTANCE AND DEEP WRAPAROUND SERVICES TO YOUNG PEOPLE AND THEIR FAMILIES AS AN ALTERNATIVE TO INCARCERATION. BELOVED VILLAGE'S MODEL FOCUSES ON FAMILY-BASED CARE AND ECONOMIC STABILIZATION AS A STRATEGY TO PREVENT AND DIVERT INCARCERATION. ACROSS ALL THREE PROJECTS--YWFC, SISTER WARRIORS, AND BELOVED VILLAGE--PROGRAMMING EXPANDED THROUGHOUT FIVE COUNTIES, WITH SISTER WARRIORS EXTENDING EVEN FURTHER INTO THE CENTRAL VALLEY AND STATEWIDE ACROSS ALL CALIFORNIA WOMEN'S PRISONS. THE FREEDOM CENTER PROVIDED THE SHARED OPERATIONAL INFRASTRUCTURE TO SUPPORT THESE PROGRAMS, AND ALSO SUCCESSFULLY BEGAN FISCAL SPONSORSHIP OF NEW ALIGNED PROJECTS. THIS YEAR'S ACCOMPLISHMENTS REFLECT OUR CONTINUED COMMITMENT TO BUILDING ECONOMIC POWER, LEADERSHIP PATHWAYS, AND HEALING SPACES FOR SYSTEMS-IMPACTED WOMEN, GIRLS, AND TRANS PEOPLE OF ALL GENDERS. OUR WORK REMAINS GROUNDED IN LIVED EXPERIENCE AND DRIVEN BY THE COMMUNITIES MOST IMPACTED BY CYCLES OF POVERTY, VIOLENCE, AND INCARCERATION.
